Office of Data Collection and Quality Assurance

- Collection of patient level data from licensed inpatient hospitals, ambulatory surgery centers (ASCs), and emergency departments (EDs)
 - Patient demographics (race, gender, age, zip code)
 - Admission information (source, type, length of stay)
 - Medical information (diagnoses, procedures)
 - Charges (total and by individual revenue code)
 - Payer categories (Medicare, Medicaid, Commercial...)
 - Facility Information

Florida Center for Health Information Exchange and Policy Analysis

- Provides governance and administrative support for the statewide Florida Health Information Exchange (HIE)
 - *Contract with Harris Corporation for HIE Operations*
- Administers the federal Centers for Medicare and Medicaid Services (CMS) Electronic Health Record (EHR) incentive program

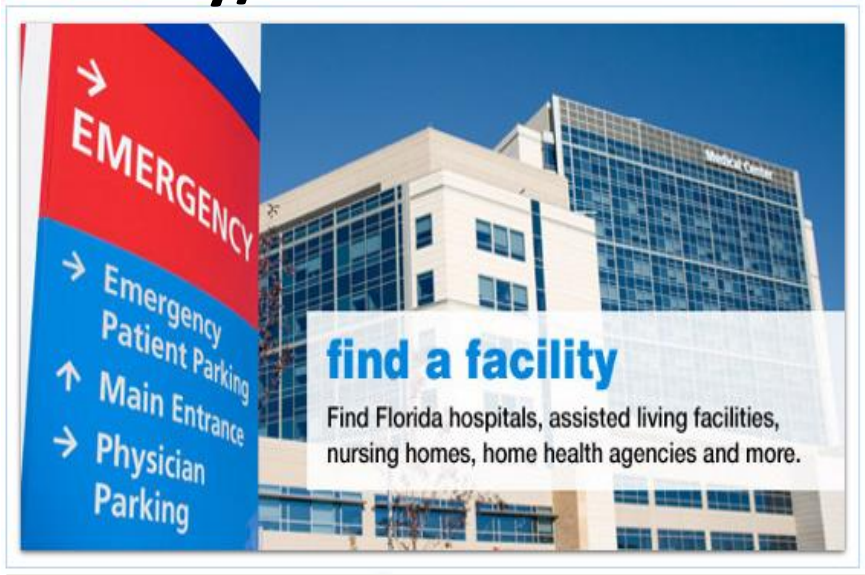

Electronic Health Record (EHR) Incentive Program

- Acute Care, Critical Access, and Children's Hospitals
- Formula based payments
 - Base amount \$2,000,000
 - Modified by number of Medicaid discharges, bed days, and other factors
- Eligible hospitals can receive payments over 3 to 6 yrs
